Wedding Makeup Contract

I. Terms and Conditions

This contract outlines the agreement and contractual obligations made on _____ (date), between Vanessa Gonzalez, hereby referred to as "**Artist**," and _____ hereby referred to as "**Client**."

In consideration of the mutual agreements herein enclosed, and intending to be legally bound hereby, the **Client** and the **Artist** agrees as follows:

- **Client** agrees to a signed contract for the **Artist** to provide the Services (as defined below) on the date and time set forth below.
- The **Artist** agrees to perform these Services for Client (and any additional persons set forth in Section V) under the terms and conditions set forth in this contract.

II. Artist's Obligation to Client

- **Artist** shall perform the Services on the date and time agreed.
- If due to any unforeseen circumstances, **Artist** is unable to perform the Services, any and all payments shall be returned to the client and **Artist** shall have no further liability or obligations to Client.
- **Artist** shall be the exclusive Makeup Artist for Client's wedding/event. To the extent **Artist** determines in her reasonable discretion, that assistants will be needed to adequately provide the Services. **Artist** will be responsible for sub-contracting such assistants.
- **Artist** shall use her own products in the provision of the services.

III. Client's Obligation to Artist

- **Client** agrees to pay the Fees in accordance with Price List set forth on Exhibit A hereto.
- **Client** is responsible for **Artist's** (and assistants) parking, travel fees, and accommodations (if applicable).
- **Client** agrees to provide accommodations for **Artist** (and assistants) if prep location is more than 80 miles from **Artist's** home.
- A travel fee of **\$1/mile** (to and from the prep location) is applicable if prep location is more than 20 miles from **Artist's** home.

- **Client** shall pay all Fees (including travel fees) in full one week before the date Services are to be provided.
- **Client** shall provide **Vanessa** with a safe and private work area at the location Services are to be performed. This location will also provide **Vanessa** with the capability of performing Services as described, by providing an appropriate area (table/flat surface) to work from, appropriate lighting, and electrical outlets if necessary.

V. Services

- **Client** agrees that **Artist** is only obligated to provide the Services that are specified in this Contract. Any additional Services requested on the Event Date will only be provided if Artist, in her reasonable discretion, determines that such additional Services can be provided in the requested time frame. Artist shall not be liable for any additional Services not completed in the requested time frame or for failing to provide any additional Services.
- Services to Be Performed on Event Date:
 - It is agreed that Artist shall provide Makeup Artistry Services and/or Hair Styling Services (in each case as agreed to on Exhibit A hereto) for Client and _____ additional members of the bridal party (as specified on Exhibit A) on the Event Date.
 - **Client** understands and agrees that only those persons who are included in this contract on Exhibit A are guaranteed Services, and only if time allows will additional persons be added, subject to payment in advance of any additional fees. **Artist** is not responsible for providing Services to additional Attendants not included in this Contract. Additional Services on the Event Date are to be paid in full, in the form of CASH/ELECTRONIC PAYMENT ONLY.

VI. Deposit

- **Client** understands and agrees that in order for **Artist** to hold Client's Event Date in their calendar, a minimum deposit of **\$100** must be paid at the time of booking. This Payment will be deducted from the Total Balance that the Client will owe one week before the Event Date. Client also understands and agrees that Artist has the right to consider other paid job offers until this Deposit has been received.

- Client understands and agrees that this Deposit is a retainer to hold the Event Date in the Artist's calendar and is non-refundable for any reason.
- Deposit can be paid in the form of Cash or Electronic payment .

VII. Balance Due on the Event Date

- **Client** understands and agrees that the remaining Balance will be due in full one week before the Event Date.

Balance of \$_____ is due on _____ (1 week before event date).

- Client understands that the balance due can be paid in the form of Cash or Electronic Payment on the day of the event.
- Gratuity is not included in pricing, and is at the discretion of the Client.

VIII. Cancellation Policy

- If **Client** cancels:
 - ▶ More than 4 weeks before Event date, then no cancellation fees will be charged
 - ▶ Less than 3 weeks before Event date, then 25% of balance is to be paid to **Vanessa**
 - ▶ Less than 2 weeks before Event date, then 50% of balance is to be paid to **Vanessa**
 - ▶ Less than 1 week before Event date, then 100% of balance is to be paid to **Vanessa**
 - ▶ If there are "*no shows*" or cancellations on the event date, involving any Attendants receiving Services that are stated on Exhibit A, Client agrees that there is *no refund* for those cancellations as set forth herein.

IX. Liabilities

- **Client** understands and agrees to give **Artist** notice of any and all known allergies that Client and/or Attendants (that are receiving Services) have to ingredients that could potentially be found in cosmetic products of any kind. These allergies are to be listed next to the Client's name or Attendant's name on the Service Sheet.
- **Client** understands and agrees that if notice is not given to **Artist** of any known allergies that Client and/or Attendants have, or if Client and/or Attendants are not aware they have, Artist and her assistants cannot be held liable for any reactions, injuries, losses, damages, costs, claims, and/or actions that may occur to Client and/or Attendants.
- Client agrees to indemnify, defend, and hold harmless **Artist** and assistants from any and all claims, demands, liabilities, obligations, losses, actions, judgments, suits, costs and damages of any kind or nature whatsoever which may be incurred by, or asserted against, Artist arising out of or in any way relating to this Agreement or the Services provided (including without limitation, any damages from any allergic reactions, injuries, losses, damages, costs, claims, and actions that may occur to Client or Attendants).
- Artist shall not be liable for any indirect, punitive, exemplary or consequential damages arising from the breach of this contract.

X. Entire Agreement

This Contract represents all the Terms and Conditions agreed upon by the parties. No other understanding or representations, oral or otherwise, regarding the agreement shall bind any of the parties. This Contract may not be amended, except in writing, and signed by both parties. This Agreement may be executed in any number of and by different parties hereto on separate counterparts, all of which, when so executed, shall be deemed an original, but all such counterparts shall constitute one and the same agreement. Any signature delivered by electronic transmission (including email transmission of a PDF) shall be deemed an original signature hereto and bind the parties.
